We are pleased to confirm and inform you that **Pineapple-Orange Foundation** is a registered "Non-Stock, Non-Profit and a Non-Government Organization (NGO)" in the Philippines through the Securities and Exchange Commission (SEC) bearing registration Certificate No. A200117673. It was registered on the 22nd December 2011 and has a lawful incorporation life of fifty (50) years.

POFi-Phils as popularly known today is carrying "Good Standing Status Certificates" issued on year 2007 and 2012 by the SEC for its valued contributions in providing social services in the country.

Since its registration, various humanitarian projects supported by POFi-Phils have taken shapes, majority of which are at incubation stage and anticipating funding supports as follows:

- E. RECOVERY AND REHABILITATION PROGRAM FOR VICTIMS OF NATURAL AND MAN-MADE CALAMITIES;
- F. SUSTAINABLE LIVELIHOOD PROGRAM FOR THE HANDICAPPED;
- G. COMMUNITY DEVELOPMENT PROGRAM INCLUDING MASS HOUSING PROJECTS VIA HOUSING COOPERATIVES;
- H. SUPPORT PROGRAM TO INDIVIDUAL OR GROUP OF FARMERS IN TERMS OF AGRICULTURAL AND FISHERIES MODERNIZATION, HIGH VALUE CROP PRODUCTIONS, AND INDUSTRIAL TREE PLANTATIONS;

Thus because of that strategic consolidation, the former website www.pofi.org is now offline (shelved) and www.pofi-usa.com being online is now catering the needs of humanitarian projects located worldwide.

Though, we at POFi-Phils as we wait for the appointed time, confirms that the above listed projects are available and ready in any eventuality of funding and project implementations.
